The approximate estimated cost is Rs 11.05 Crores (Rupees Eleven Crores and five lakhs only). The estimated cost however, is given merely as rough guide.

The Contractor / Firm / Company should have completed atleast one work of similar nature costing not less than 80% of the approximate estimated cost mentioned above or atleast two works of similar nature costing not less than 60% of the approximate estimated cost mentioned above, in the last 5 years ending last day of the month previous to the one in which the Tenders are invited now.
